Mine/ERW Risk Education: During the 1st quarter of 1397, in total 197,082 people received mine/ERW risk education in 384 communities. Of this figure, 15.2% were female, 26.1% were male and 58.7% were children.

Victim assistance achievements: During this quarter a total number of 4,150 persons with disabilities received physical rehabilitation services in 3 regions, 9 provinces and 28 district with the following details: 1,094 (26%) of beneficiaires were women, 1,547 (37%) Men, 762 (19%) Girls and 747 (18%) Boys.

Workforce: The MAPA workforce for the 1st quarter of 1397 was 5,599 people, out of which 4,547 staff (81%) were part of the humanitarian organizations and 1,052 (19%) were part of commercial companies. Out of 49 national and international mine action organizations, 14 NGOs and 2 commercial companies were operational during the quarter.

Funding Status (1397 / 2018): The table below demonstrates funding target and budget which has been confirmed for the year 1397. Funding to the MAPA is channeled through the UNMAS-managed Voluntary Trust Fund (VTF) and bilaterally through donor contracts with implementing partners.
