Workforce: The MAPA workforce for the current quarter is 6,989 people, out of which 5,575 (79.7%) is part of humanitarian organizations and 1,414 (20.3%) part of commercial companies. Out of 49 national and international mine action NGOs and commercial companies 11 NGOs and 1 commercial company were operational during the period from July to September.

Funding: Through the United Nations Mine Action Service (UNMAS) managed Voluntary Trust Fund (VTF), donor contributions are channeled to the implementing partners. Bilateral contributions are channeled directly to the implementing partners.

Highlight of the Month: The Directorate of Mine Action Coordination (DMAC) and The United Nations Mine Action Service (UNMAS) celebrated the **International Day of Peace** in Shamshad TV Studio, Kabul. The event brought together civil society, academics institutions, international organizations, embassies, government and individual citizens in a global partnership in support of peace in the country as well as reiterating their commitment to work towards the goal of a mine-free Afghanistan by 2023.

Workshop on finding new methodologies in clearing Anti-Vehicle Mines was organized on 15th & 16th of August 2017 in MDC – Kabul. The workshop was participated by over 30 DMAC/UNMAS and IP representatives. As a result of this workshop a roadmap document was developed which will help DMAC and the IPs to find more effective ways in clearing the AV mines in Afghanistan.

During the reporting quarter, **ANDMA signed MoUs with the Ministry of Education and Ministry of Information and Culture** for the provision of support to the MAPA.
