


MACCA PROVIDES BRAILLE SCRIPT AND SIGN LANGAUGE TRAININGS TO SCHOOLS TEACHERS

For the first time Mine Action Coordination Center of Afghanistan (MACCA) conducted ten days trainings for 70 teachers on Braille script and sign language in Kabul city. The mentioned trainings were conducted by ANAD and SERVE organizations in Ayesha High School and the aim of these trainings were how the trained teachers bear with deaf and blind students in their

schools, so they could have the rights to become literate such as other children.

At first it was thought that learning of sign language and Braille script will be very difficult for teachers to learn and they will not be interested in it, but at the end of the training it was realized that it is very easy and will be able to learn it in a very short time.

Thementioned trainings were just introducing the elementary parts of brail scripts and sign language, but it is proposed to continue such trainings for all teachers in the near future to learn it in a good way and share their lessons learnt with all other teachers as well.

At the end of the training teachers were evaluated and it showed that they were satisfied and happy about conducting of such trainings, and these trainings will build capacity of children with disability.

Getting awareness regarding ability of disabled people is very important step for their admission in schools and community so for the mentioned points conducting of such trainings are very necessary. In result of conducting these two trainings for more than 70 disabled children would be pave the way for a better learning.


securing lands for infrastructure development.





In **November 2012**, there were 15 casualties due to ERW recorded in Afghanistan (data as of November 2012).








MINE ACTION BENCHMARKS IN AFGHANISTAN

Ottawa Convention:

As part of its obligations under the Ottawa Convention, Afghanistan aimed to clear all emplaced anti-personnel (AP) mines by 2013; destroy all known AP mine stockpiles by 2007; provide mine risk education and assist mine survivors. To note, the Ottawa Convention is about the removal of AP mines, and not of anti-tank (AT) mines or ERW. However it is equally important to ensure that the other hazards are not forgotten whilst the focus is on meeting the Ottawa Convention obligations. In March 2012, the Government of Afghanistan applied for 10-year extension of its deadline to clear all AP mines by 2023. All AP mine stockpiles have already been destroyed.
