Mine Action Programme of Afghanistan (MAPA) Quarterly Update 4th Quarter 1396 (January - March 2018)

This fast facts covers the statistics for the 4th quarter of 1396 (January to March 2018), the progress so far in 1396 and the achievements of the MAPA since the beginning of the programme. It also encompasses the MAPA funding and achievements over a varying time period.

Victim assistance achievements: During this quarter a total number of 4,150 persons with disabilities received physical rehabilitation services in 3 regions, 9 provinces and 28 district with the following details: 1,094 (26%) of benifeciaires were women, 1,547 (37%) Men, 762 (19%) Girls and 747 (18%) Boys.

Workforce: The MAPA workforce for the 4th quarter was 5,370 people, out of which 4,318 (80%) was part of humanitarian organizations and 1,052 (20%) part of commercial companies. Out of 49 national and international mine action organizations, 13 NGOs and one commercial company were operational during the quarter.

Funding status (1396 / 2017): The table below displays the funding target and the budget which had been confirmed for the year 1396. Funding to the MAPA is channeled through the Voluntary Trust Fund (VTF) managed by UNMAS and bilaterally contracted by some donors with the implementing partners.
