Explosive Ordnance Risk Education (EORE): During the 1st quarter of 1400, in total 58,182 people received explosive ordnance risk education in 250 communities. Out of the given figure, 51% were female and 49% were male.

Workforce: The MAPA workforce for the 1st quarter of 1400 was 5,023 people, out of which 4,851 staff (96.5%) were part of the humanitarian organizations and 172 (3.5%) were part of commercial companies. Out of 49 national and international mine action organizations, 12 NGOs and one commercial companies were operational during the quarter.

Funding Status (1400/ April 2021 – 31-Mar 2022): The table below demonstrates funding target and budget which has been confirmed for the year 1400. Funding to the MAPA is channeled through the UNMAS-managed Voluntary Trust Fund (VTF) and bilaterally through donor contracts with implementing partners.
